MESSAGE FROM CO-CHAIRS

Last year was a rewarding year for CCAB and our members. We launched some exciting initiatives around procurement, increased our membership, led the way in Indigenous data and research, and forged some new partnerships and collaborations. We had the privilege to engage with communities, Aboriginal businesses, thought leaders, government leaders and corporations, whose insights and support helped us as an organization inform our priorities, strategic directions and best practices.

New membership in the CCAB came from sectors that were historically less active with our organization, for instance, we now have members from tourism and IT including companies like Air Canada, Apple and LinkedIn. There was a positive shift with corporate Canada and we saw many industry sectors wanting to build relationships with Indigenous communities.

Our Progressive Aboriginal Relations (PAR) certification program continued to help companies with a number of key issues that non-Aboriginal companies must consider when building valuable relationships with Aboriginal businesses and communities. Key issues like procurement, employment, engagement, and investment in Aboriginal businesses and communities.

The overall financial health and stability of CCAB continued through the support and dedication of its staff, membership and supporters. Our annual events fit so aptly with our mandate that they created opportunities for networking, building partnerships and fostering business relations between Aboriginal and non-Aboriginal businesses. Through the CCAB's events, galas, and award ceremonies we are engaged with our communities, governments, businesses and Indigenous entrepreneurs and provide valuable opportunities for them to connect with one another. We were fortunate to connect with so many innovative thought leaders and supporters from across all business sectors.

We celebrated excellence by recognizing the best and the brightest Indigenous entrepreneurs, business leaders, mentors and innovators through our national award recognition programs. The Board, it's Executive and Committees worked diligently on positioning CCAB as the leading authority to improve and facilitate a national approach to Aboriginal procurement opportunities through the Supply Change initiative. Procurement, an important driver of economic reconciliation generates revenue for Aboriginal businesses and forms relationships with corporations and government. By developing the largest membership of corporations committed to increasing Aboriginal participation in corporate supply chains, CCAB continued to provide ease of access to procurement bids and direct contact between committed Aboriginal procurement champions and Certified Aboriginal Businesses. It has been particularly rewarding to see our efforts acknowledged through our membership and the growth of our Aboriginal Procurement Champions. At the end of the first year of our three-year Aboriginal procurement campaign, we now have 51 Champions!

Our overall financial health remained positive despite moving to a larger space and launching a new national strategy, thanks to the increase in membership and research partners.

As co-chairs of the Board, we are grateful to and thank our Directors and committee members for their wisdom in helping to steer the direction of a dedicated organization that is leading the way toward economic reconciliation and opening doors and possibilities to a brighter future and prosperous Aboriginal economy.

We also want to acknowledge and thank our many sponsors, donors, members, volunteers and staff past and present for all the tremendous work they have done and the support they have given and continue to give.

If ever there was time to become a member of the CCAB, it is now – join us and let's invest in Aboriginal business, promote prosperity, and help grow an economy that works for everyone!

MESSAGE FROM THE PRESIDENT & CEO

Thank you for making 2018 a remarkable year of change and progress. Not only did CCAB welcome a new Chief Operating Officer, staff, board of directors and CCAB members but as an organization we have done an incredible job at expanding our outreach while strengthening our programs.

I was fortunate to travel across Canada and talk to heads of government, industry, organizations, and communities. I often start my talk with a statement "Economic reconciliation occurs when Aboriginal communities are no longer managing poverty but are managing wealth." The total dollar value created by the Aboriginal economy is well over \$30 billion and growing since 2016 and the potential that Indigenous communities hold could quadruple that if communities had access to the same resources and opportunities as the average Canadian population.

An important driver of economic reconciliation is Aboriginal procurement. Greater demand for procurement became evident through a Canada-wide survey conducted in partnership with Environics Research of Aboriginal and non-Aboriginal Businesses. Findings showed a mutual interest in improving and facilitating procurement opportunities not only for the vast revenue that Aboriginal procurement generates but also for relationship building and partnership prospects.

As a result, we launched Supply Change: CCAB's Aboriginal Procurement Strategy, which is a campaign to create an unprecedented, national approach to Aboriginal procurement by developing the largest membership of corporations committed to increasing Aboriginal participation in corporate supply chains. The campaign focuses on highlighting entrepreneurial opportunities and value of Aboriginal procurement relationships. It builds on the important work that CCAB has done to bring Aboriginal and non-Aboriginal businesses together in support of economic reconciliation.

In May we made a significant announcement and Mark Little, Suncor's COO, became the inaugural co-chair of our Aboriginal Procurement Champions.

Mark led by example and through his participation and experience, and that of Randy Moore from Bee-Clean Building Maintenance and our co-chair of CCAB's Board of Directors, we went to Ottawa to discuss our Aboriginal Procurement Strategy with members and influencer's in the Federal government. Our "Day on the Hill" meetings and VIP reception the evening prior, were on the mark and were met with great interest and feedback. Meetings, letters and follow-up calls were made to all participating ministries and department heads discussing an effort to raise the Federal percentage of procurement from Aboriginal businesses to 5%, which would grow their supplier diversity outcome targets and drive over a billion dollars to the Aboriginal economy. This is just federal, if we raised the effort for all levels of government we could see nearly \$24 billion added to the economy via our Aboriginal businesses.

As part of the strategy, we introduced the Aboriginal Procurement Marketplace, a digital platform designed in partnership with Toronto-based tech firm, tealbook. Procurement Champions have direct access to the largest directory of Certified Aboriginal Business members in Canada. We now have an advanced two-way platform to deliver profiles and enable direct contact and dialogue with the tools to accelerate procurement contracts for Aboriginal businesses. The platform allows Indigenous entrepreneurs to communicate with each other, to share ideas, and utilize each other within their own supply chains. We have created an information superhighway that allows for the first time the opportunity for leading companies to have full and easy access to the talent, skills and innovative spirit offered by Canada's Aboriginal business and entrepreneurs.

Our voice and influence continue to reach government departments at all levels. CCAB is the clear leader in understanding the size and scope of the Aboriginal economy in Canada and the global impact beyond. We understand about the enormous potential in the Indigenous community and are active in promoting awareness and change.



A profound year for our Research department, CCAB was recognized as the foremost centre for data on Aboriginal business in the country. New data collection gathered from Aboriginal privately- and community-owned businesses, while leveraging our existing data, drove insight and advocacy in three major topic areas: Procurement, Trade and Export, and Technology Innovation and Future of Work. Putting CCAB's cutting-edge research on the map, the Organization for Economic Co-operation and Development (OECD) recognized CCAB as having the best data on the Aboriginal economy internationally. We were fortunate to build out new relationships with corporate and government allies committed to increasing prosperity in Indigenous communities and to understand what impact digital innovation and the future of work have on the Aboriginal economy. Our work on government procurement demonstrated that Aboriginal businesses could supply 24% of the Federal supply chain. We worked with Global Affairs Canada that informed the progressive trade agenda about the support Aboriginal businesses needed to receive to compete globally.

I am proud of our past year and look forward to what the future holds. I commend the CCAB team. Our structure of independent thinkers and collaborators are deeply immersed in their fields of expertise making us more efficient and able to work more precisely and effectively. Our strong network of members and partnerships enhance our ability to put our resources and practices to the highest and best use.

Thank you to all who support the CCAB with your continued commitment to Indigenous inclusion and engagement.

CERTIFIED ABORIGINAL BUSINESS (CAB) PROGRAM

The Certified Aboriginal Business program (CAB) has been designed to increase public and private-sector business opportunities for CCAB's Aboriginal business members.

Certification System

Aboriginal business members are provided with a formal certification that can be used for marketing and bid packages, identifying them as a Certified Aboriginal Business.

Since the relaunch of the CAB Program in December 2016, CCAB has seen an increase in the number of Aboriginal Businesses registering (almost up 50% from 2017) to take advantage of more procurement opportunities. The eligibility component of the CAB program has been redesigned to improve the ease of application and to increase the number of opportunities for Aboriginal businesses and CCAB member companies to work together.

ABORIGINAL PROCUREMENT STRATEGY

Aboriginal procurement is an important driver of economic reconciliation and development for Aboriginal communities due to the revenue procurement generates for Aboriginal businesses as well as the relationships formed through corporations and governments establishing procurement agreements with Aboriginal businesses.

The focus on Aboriginal procurement has grown significantly in recent times, resulting in greater demand for procurement outcomes particularly from Aboriginal businesses, with Canadian corporations and governments also seeking opportunities to grow their outcomes in Aboriginal supplier diversity.

Supply Change, CCAB's Aboriginal Procurement Strategy was developed following a Canada-wide survey of Aboriginal and non-Aboriginal businesses, conducted by the CCAB in partnership with Environics Research. The survey showed intense mutual interest in improving and facilitating procurement opportunities as another key element of economic reconciliation. This message was also reflected in the CCAB/Sodexo 2017 Indigenous Business survey, with 80% of Canadians supporting Indigenous business as a pathway to healing Canada's relationship with Indigenous people. The survey results provided clear insight into the needs of both Aboriginal businesses and Canadian corporations and how CCAB can make the greatest positive impact to Aboriginal procurement.

Supply Change aims to develop both the largest membership in Canada of corporations committed to Aboriginal procurement and largest online directory of Certified Aboriginal Businesses (CAB) as well as:

- Increase private sector and all levels of government engagement in Aboriginal procurement among senior leaders and procurement officers;
- Increase Aboriginal participation in the supply chains of Canadian corporations and governments;
- Enhance the capacity and profitability of Aboriginal businesses;
- Create a forum for sharing Aboriginal procurement best practices; and
- Eliminate barriers Aboriginal businesses face when engaging in corporate and government supply chains.

Supply Change achieves these outcomes through it's five key pillars.

Aboriginal Procurement Champions Group:

A high-profile group of corporations and government entities making public commitments to procure more from Aboriginal businesses. Co-chaired by JP Gladu, President and CEO, CCAB and Mark Little, COO, Suncor. Together the co-chairs recruit organizations to the Champions group. Procurement outcomes achieved by organizations who are part of the leaders' group are tracked and measured through the PAR program.

Aboriginal Procurement Campaign:

A national campaign that leverages the profile of the Champions group to increase engagement in Aboriginal procurement through sharing success stories that highlight the benefits of Aboriginal supplier diversity. This leads to more organizations joining the Champions group, creating more procurement opportunities for Aboriginal businesses.

Certified Aboriginal Businesses (CAB):

The CAB designation provides organizations and communities with the assurance that Aboriginal procurement opportunities are going to businesses who have been independently precertified as at least 51% Aboriginal owned and controlled. The number of CAB businesses has doubled in size over the past year and is the largest, fastest growing directory of certified Aboriginal businesses in Canada. Research found that 82% of corporate respondents regard CCAB's CAB designation useful for enhancing Aboriginal procurement outcomes.

Aboriginal Procurement Best Practices:

Sharing of Aboriginal procurement success stories enable more Aboriginal businesses and corporations to better work together to increase Aboriginal procurement outcomes. Best practices are hosted on TFAB as part of the capacity building CCAB offers Aboriginal businesses and form content for the Aboriginal procurement campaign.

The Aboriginal Procurement Marketplace is an online portal that acts as a two-way directory between CCAB Certified Aboriginal Businesses (CAB) and procurement representatives from the Aboriginal Procurement Champions.

All CAB companies have a marketing profile that can be searched by Procurement Champions when they are looking to go out to market on bids. In turn, each Champion provides an internal procurement representative identified in the marketplace for CAB's to contact. One of the key elements of the portal is that Champions can post mid-level procurement opportunities to connect Aboriginal businesses to opportunities that are not available on conventional procurement platforms.

CCAB is partnered with tealbook on the creation and management of the Aboriginal Procurement Marketplace. Tealbook is an industry partner of SCALE. AI (Supply Chains and Logistics Excellence. Artificial Intelligence) of which CCAB is a non-profit supporter. Tealbook uses the latest technology to improve the quality of partnership decisions, reducing effort and cycle time while increasing trust for all parties. By combining machine learning, leading software development, procurement and operations expertise, the tealbook team transforms how companies improve their existing buyer-supplier partnerships and build new lasting ones.

To support this growing Aboriginal economy, TFAB has transformed into an important vehicle for Aboriginal and non-Aboriginal businesses striving for mutual success across Canada.

Progressive Aboriginal RELATIONS

Canadian Council for J Aboriginal Business The Progressive Aboriginal Relations (PAR) program continues to encourage companies to evolve and participate in a growing Aboriginal business economy across Canada. The fastest growing segment of Canada's population comes within its Aboriginal community, which is also becoming increasingly urbanized. PAR continues to be the only corporate social responsibility assurance program with an emphasis on Aboriginal relations.

These four performance areas; **Leadership Actions, Employment, Business Development, and Community Relationships** provide a foundation for the PAR program and represent the core components to successful positive business relations with the Aboriginal community.

LEADERSHIP ACTIONS

Leadership Actions are defined as actions to reinforce an organizational focus on Aboriginal relations by leaders of the organization. Such actions have an impact in achieving and sustaining good results in all PAR drivers. These actions include setting and cascading a clear commitment and policy, identification and communication of the community of interest, scheduling self-assessment exercises against PAR criteria to review status, and the application of a structure to drive and help sustain the commitment to positive Aboriginal relations across the organization.

EMPLOYMENT

Employment is defined as the commitment of resources (time and money) to achieving equitable representation of Aboriginal persons in the workplace. This involves recruiting and retaining Aboriginal talent, supporting their career development and advancement, and promoting mobility of Aboriginal employees throughout employment sectors and levels. This driver also includes supporting cross-cultural awareness and/or cultural sensitivity training, and providing training and support for existing or prospective Aboriginal employees through specific programs or actions.

BUSINESS DEVELOPMENT

Business development is defined as the commitment of resources (time and money) to the development of business relationships with Aboriginal-owned businesses. These activities, which include procurement, are sustained through mutual benefit. Capacity building and mentorship also directly relate to sustaining, enhancing or developing future business development.

COMMUNITY RELATIONSHIPS

The Community Relationships driver is broken out into two components: engagement and support. Engagement is defined as providing time and resources to develop and sustain positive and progressive relationships with Aboriginal communities, groups and stakeholders. Engagement can include communications, information sharing, involvement in events and activities, and partnerships. Support is defined as a commitment to develop positive and progressive relationships with Aboriginal communities, groups and stakeholders by providing financial and/ or in-kind support. These components work together to nurture and sustain positive and progressive relationships. Those companies that are viewed as part of the community have a far better chance of success in sustaining good relationships, versus those that go into the community to give an occasional presentation.

PAR Committed Criteria

The PAR Committed Criteria is a progressive and phased process, developed from questions selected from the full PAR Certification Criteria, to assist a company just starting out in PAR. A company's involvement in PAR indicates its commitment to the continuous improvement of Aboriginal relations, and intention to undergo external verification of its performance in the future. The PAR Committed Criteria is comprehensive but user friendly with three specific progressive phases, emphasizing self-assessment/gap analysis, annual feedback to assist companies in setting a stable foundation for positive Aboriginal relations, and for making a future submission for CCAB PAR Certification. Each phase of the PAR Committed Criteria should take no longer than one year to implement. Following successful completion of Phase Three of the PAR Committed Criteria level.

PAR Certified Criteria

The PAR Certification Criteria was designed for organizations at the Third Phase PAR Committed Criteria implementation level or above, to help grow and sustain their focus on positive Aboriginal relations. This level of participation offers companies the opportunity to provide the highest level of assurance to their stakeholders that they are invested in a strong commitment to Aboriginal relations. Unlike the PAR Committed Criteria, which is a three-phase progressive format, the PAR Certification Criteria is one set of questions and is made up of four comprehensive sections covering each PAR Driver (Leadership Actions, Employment, Business Development and Community Relationships). In addition to the standard PAR submission review process, adjudication for PAR Certification Criteria includes a scheduled and detailed on-site verification exercise (on-site discussions with company personnel as well as interviews with external Aboriginal stakeholders). These inputs combine to create a PAR Submission Review that is used by the PAR Jury to assist their deliberations in regards to awarding the company PAR standing at the Bronze, Silver or Gold level.

Any business or organization that wants to partner with a First Nation, Métis, or Inuit community and business can undertake the PAR process.

THE CENTRE FOR DATA ON ABORIGINAL BUSINESS

CCAB Research continues to understand and develop deep insights into the Aboriginal business space. In fall 2018, the Office of the Chief Economist at Global Affairs Canada validated Promise and Prosperity: The 2016 Aboriginal Business Survey, ensuring a high standard of survey and data quality.

Following consultations with its 13-member nations, the Organization for Economic Cooperation and Development (OECD) recognized CCAB as having the best data on Aboriginal business and economic participation. CCAB Research has focused its efforts on three main buckets: Procurement, Trade and Export, and Future of Work. In the past year, research activities were ramped up, partnering with Big River Analytics to combine the analytical tools of economics with the insights of business leaders, and build the case for Aboriginal procurement in corporate and government supply chains. At the same time, CCAB Research organized successful events for government partners to increase engagement and accelerate the movement of research findings and government policy and program information.

With support of Vancity Indigenous community initiatives, CCAB conducted a research project on the Aboriginal private economy in BC, comparing existing data from our Promise and Prosperity Series with data from a new survey designed for Vancity. Data highlights provided a snapshot comparison of the state of BC businesses from 2015 to 2018. With over 15 projects in various stages of project management and a dozen different corporate and government funders, this has been a banner year for research at CCAB with unprecedented results.



RESEARCH NATIONAL PERSPECTIVES ON INDIGENOUS ECONOMIC DEVELOPMENT CHANNELING BUSINESS GOALS INTO CHANGE THAT WORKS

Over the summer, CCAB Research conducted in-person interviews in more than 100 Indigenous communities across Canada as part of the National Perspectives on Indigenous Economic Development research project.

This study is the first of its kind – providing insights directly from Indigenous community and business leaders who are driving prosperity in urban and on-reserve economies. We listened to local Chiefs and Councilors, Indigenous Economic Development Corporations, Economic Development Officers, and financial lenders as they explained the economic realities of Indigenous communities on the ground. CCAB Research will share the findings from those community visits in a series of reports slated for later in 2019. The first report will centre around the community relationship to economic development. The second report will investigate the governance and operations of the development corporation, as well as the subsidiary businesses, investments and partnerships within its purview. The CCAB is shining light on aspects of the Indigenous economy like it never has before.



TOP TIER RESEARCH EVENTS AND ROUNDTABLES

On September 26, 2018 CCAB Research hosted an exclusive roundtable discussion and networking event with members of the Canada Research Coordinating Committee, focused on strengthening Indigenous research and development, human capacity, partnerships and knowledge sharing in Canada.

Prior to the National Dialogue in Ottawa, the roundtable was a key exercise for agencies to understand how research in Canada can better serve Indigenous Peoples and contribute to reconciliation. As a result of this funding opportunity, the research team received two connection grants with the National Aboriginal Trust Officers Association (NATOA), which we will use to share best practices on how to invest, manage and administer an Indigenous trust. In addition, we will hold a Design Thinking workshop to explore the ways in which Aboriginal businesses and workers are adapting to an ever-changing world of work. CCAB Research continues not only to do leading research but significant outreach to ensure business intelligence is shared and actioned to the benefit of Indigenous communities across Canada.



RESEARCH SKILLS FOR THE FUTURE

ACCESS AND OPPORTUNITIES FOR INDIGENOUS LEADERS

On April 24, 2018, CCAB Research partnered with Tata Consultancy Services to kickstart the conversation on barriers to Indigenous participation in Science, Technology, Engineering, and Mathematics (STEM) and what helping to improve the quality and delivery of STEM education can do for Aboriginal businesses and employees in the new economy.

The "Skills for the Future: Access & Opportunities for Indigenous Leaders" brought together Indigenous entrepreneurs in the STEM fields from across Ontario, as well as diverse stakeholders in banking, education and training, public office, social services, and technology, to participate in lively breakout sessions and a plenary discussion to report back to the group the findings of the day. Following the success of a TCS-CCAB interactive workshop, CCAB and TCS produced a joint report on increasing opportunities for Indigenous leaders in STEM.

RESEARCH FIRST NATIONS EXPORT FORUM SUPPORTING EXPORT DEVELOPMENT IN ONTARIO

The First Nations Export Forum was held in Toronto on March 8th, 2018. This event brought together Aboriginal business owners, government officials, subject matter experts and Aboriginal Economic Development Corporations to examine the issues, challenges, successes and goals surrounding the export of Aboriginal products and services.

The Forum also acted as an information sharing opportunity for the government programs and services currently available to Aboriginal businesses in the export industry. Significant growth among Aboriginal businesses in Ontario signals an opportunity for many to benefit from access to larger and alternative markets; however, many Aboriginal businesses encounter difficulties when expanding sales and services beyond their local customer base. To close this gap, CCAB Research hosted an exportoriented Aboriginal business gathering, co-sponsored by the Ministry of International Trade of Ontario (MIT) and the Ministry of Indigenous Relations and Reconciliation of Ontario (MIRR), focused on increasing access to and awareness of existing export development supports to help advance economic and business development opportunities for Indigenous Peoples in Ontario.
