Committed Level Deadline and Requirements

Deadline: Ongoing

- III. PAR Verifier booked for high level feedback. Contact your verifier of choice directly to book this (see list of verifiers below). Please email Luanne Whitecrow (lwhitecrow@ccab.com) and inform her of your selection.

Price of Committed Review by Verifier

- ✓ \$1,000 + HST paid directly to Verifier. Please contact your verifier for the invoice.
- ✓ Verifiers must be booked upon completing either Phase level. All reports will be required to be reviewed by PAR Verifier, and cleared before accessing next level.
- ✓ The Vancouver Gala is in September of every year. Companies that reach the PAR Committed Level will be announced onstage.

Certified Level Deadline and Requirements

Deadline: April 1st of every year (5PM EST)

To qualify for the PAR Certified Level all following documentation must be in by April 1st.

Required Documents

- I. **Reporting Period is 3 years.** You need to submit reports for years 2016, 2017, and 2018 into one report called "2019."
- II. Application Fee to CCAB (\$1000 + HST). Please email Luanne Whitecrow (Iwhitecrow@ccab.com) for invoice.
- III. PAR Verifier booked for *Onsite Verification* to company office by May 1, 2019. Contact your verifier of choice directly to book this (see list of verifiers below). Please email Luanne Whitecrow (lwhitecrow@ccab.com) and inform her of your selection and date.
 - ✓ Onsite verifications will start April 15, 2019 and must be complete by July 1, 2019.
 - ✓ The Jury will meet in late July to award company standing.
 - ✓ The Vancouver Gala is in September 2019. Companies that reach the PAR Certified Level will receive a certificate onstage.
