Residential Building Site Visitors



Visitors, suppliers and subcontractors, have the potential to get hurt on building sites. It's your responsibility as the homebuilder to keep them safe.

Enforce strict rules on safety as most purchasers will want to visit their building while it's under construction.

Accessing a building under construction is dangerous, especially when visitors aren't provided with adequate personal protective equipment (PPE). Visitors are navigating through an unfamiliar environment, often with unstable stairs and unprotected openings.

As the home building contractor, you can achieve building site safety through control, communication and documentation.

Control

- Grant access by appointment only.
- Create procedures and guidelines on who, when and how a person can access the site.
- Don't allow children on site.
- Require visitors to wear personal protective equipment (PPE), such as hard hats and safety glasses.
- Install security alarms and motion sensors.
- Build fencing or enclose the building.
- Cover or fence holes on the floor/ground.
- Set up guards and mark unfinished balconies and other potential fall hazard areas.
- Correct and protect other unsafe areas on site.

Communication

- Require purchasers to sign your Site Visit Policy.
- Explain how the building process works, as well as your expectations of the purchasers.
- Agree upon the number of times purchasers can access their building under construction and set up appointments.
- Keep the purchasers, suppliers and subcontractors informed on who has access to the site, as well as when and how they can access it.
- Require visitors to check in immediately upon arrival.
- Post signs to communicate that the building site is restricted to the general public.
- Understand the purchasers' needs and vision for the building, and provide them with regular updates and progress reports.

Residential Building Site Visitors (continued)

Documentation

- Ensure that the purchasers agree on and sign a Site Visit Policy. See attached example.
- Develop and provide a brochure on your Site Visit Policy, including information about health and safety requirements, supervised access to the site and no children allowed on site.
- Check your federal, provincial and/or territorial occupational health and safety jurisdiction for rules, restrictions and requirements for accessing a construction site.
- Include a clause in your sales agreement with the home purchasers that restricts your liability if they get injured on site.

You can keep your building site safe for visitors by using control, communication and documentation.

Make the effort to maintain a good working relationship with the purchasers, suppliers and subcontractors.
